FAQs

Q: Am I eligible to apply for this trainee program?

A: To be eligible for this program, you must:

- Have completed the CHC43515 Certificate IV in Mental Health Peer Work
- be a mental health peer worker with at least 2 years full time equivalent mental health peer work experience
- have an interest in training and want to become a trainer and assessor
- be able to attend all face-to-face training days
- be available for 1 day per fortnight of casual employment for mentoring and support (study leave options for those who are employed)

Q: What is the Certificate IV in Training and Assessment?

A: The TAE40122 is the latest version of the Training and Assessment qualification (released on 8 December 2022) that all VET trainers and assessors are required to have. It is a nationally recognised qualification that has 12 units of competency with the following being core (mandatory):

Q: Can I get Credit or Recognition of Prior Learning for the Certificate IV in Training and Assessment?

A: Depending on your existing qualification/s, skills and knowledge, you may be eligible for Credit Transfer (CT) or Recognition of Prior Learning (RPL). MRWED offers both of these pathways and any intention to apply for this can be made upon enrolment.



Q: What if I can't make all the face-to-face training dates?

A: Participation in this trainee program requires attendance at all the outlined training dates. In the event of sickness or compassionate/compelling reasons, alternative arrangements may be made with MHCC via MRWED.

Q: What if I can't make all the MHCC casual work days?

A: Participation in this trainee program encourages engagement with all casual work days to best support you in your course progress and application of course knowledge to real world tasks and skills in MHCC's RTO. Casual employees do not get paid for any days not worked. In the event of sickness or compassionate/ compelling circumstances, alternative casual employment dates may be organised between MHCC and the trainee.

Q: When will I get paid?

A: Payment will be made fortnightly processed on a Wednesday subject to the submission of a casual timesheet. Reimbursements for any transport or meals are made fortnightly upon receipts and a reimbursement request form being submitted to MHCC via training@mhcc.org.au

Q: What happens after the trainee program ends?

A: Upon successfully completing the TAE40122 Certificate IV In Training and Assessment, you will receive a Certificate from MRWED. You will have also gained paid experience working for an RTO and delivering supervised training. There may be casual and/or part time employment opportunities for trainees to be engaged with MHCC after the program ends. Alternatively, you may also apply for training and assessment work with other RTOs.
